Wildlife Report:

ODFW Wildlife License Ramps Up Need for Classes

ODFW just completed its first "cycle" of certification licensing for wildlife control. The road to getting enough credits was a little bumpy. What's clear is there is a need for more classes on wildlife issues.

OPCA has made an effort to always provide some wildlife credits. A certificate will be provided to those who take an approved class at an OPCA seminar. In the future, we will identify topics that earn credit. The next opportunity is a three hour bird class at our High Desert Seminar, June 2. Courses on rodents receive partial credit.

There are other ways to earn credit. Last year ODFW offered a **spring seminar** with approximately six hours of recertification credit. It is unclear if that event is going to happen this year. This event is held in Salem in April.

Also earn credit by **reading articles**: 1/4 hour credit for each article you read. **Online classes** are also available. Since the links are rather long, we posted them on our website, Go to **www.opca.org** and find the link on the main page for ODFW credits.

OPCA Scholarship Applications Due April 30

The applicant must be nominated from a current OPCA member firm whose active membership has been in good standing a minimum of three consecutive years.

Graduating high school seniors, other high school graduates and applicants with G.E.D equivalent will be considered. The applicant must attend an accredited college university, trade school, or institute of higher learning. Also, transcripts may be requested if required by the institution to which the applicant has applied.

OPCA Government Affairs Update

Oregon Wraps up Short Session

The "short" session of the Oregon Legislature wrapped up on March 3, about a week earlier than it was scheduled to run. This could be the result of having a majority of one

party. If that party decides not to take on an issue, it doesn't and everyone goes home early. In recent years democrats have gained more seats and the Oregon House has become more liberal. On the senate side, it's a little more balanced. Moderate members have more control.

An example of this is the so called "cap-and-trade" proposal that would require businesses to purchase credits to offset their carbon emissions. The legislature basically decided to drop the issue as amendments started coming in. Had it not done that, the session would have probably gone the entire schedule time.

Another major proposal is the

legislature's response to the recently enacted federal tax law. The debate relates to the state's response to a new federal rule allowing businesses that pay their taxes on their owner or shareholder's personal tax filing to deduct 20 percent of their income before taxes. Since Oregon relies on personal income taxes as the primary source of revenue, a



deduction of this kind would significantly reduce the "windfall" of revenues the state would receive from the expanded tax base of the new federal law.

The fight on this issue was mostly in the House Revenue Committee between Gov.

Kate Brown, a Democrat, and Republican Rep. Knute Buehler of Bend. (Rep. Buehler is running in the Republican primary in May so he can run against Brown in the fall.)

These two tax bills were drafted in reaction to the sweeping new federal tax law passed by congressional Republicans in Washington. Oregon automatically connects to several federal tax definitions that affect how much people and businesses pay in income taxes.



The committee approved both measures. Senate Bill 1529 would limit a corporate tax break involving overseas profits. The second, Senate Bill 1528, involves business owners who pay personal state income taxes — as opposed to corporate taxes — on their company's profits. The Senate has passed both bills.

The House committee changed the overseas profits bill to direct that the one-time financial gain — estimated to be about \$140 million — go toward helping to reduce the state's huge pension debt.

The committee is following the governor's plan to use that money as incentives to state and local agencies that pay off their debt more quickly.

But Rep. Buehler said that it is "not responsible" to put more money into the pension system without making other changes to reduce the cost of benefits.

As an alternative, Rep. Buehler proposed that \$50 million of that one-time gain should go toward shoring up the state child welfare system. As he's campaigned for governor, Rep. Buehler's repeatedly accused Governor Brown of endangering the safety of children in the foster care system.

Democrats countered that this was not a good use of those one-time funds and they voted the bill out of committee over the opposition of all the Republicans.

Rep. Buehler tried again on SB 1528, which deals with so-called "pass-through businesses" that are subject to personal income taxes.

He and other Republicans on the panel sought to preserve the additional tax break, saying it will help hard-pressed business owners without causing financial problems for the state.

Rep. Buehler offered an amendment to preserve that break — and to implement higher tobacco taxes that could be used to boost funding for the child welfare program. Democrats also rejected that approach and won on a party-line vote.

All told, SB 1528, means Oregon would pick up about \$258 million more in pass-through taxes in the current budget cycle than it would have if the state simply followed the new federal tax definitions.

The bills were passed by both houses and now sit at the Governor's desk for signature. There has been quite a bit of discussion and speculation about whether Governor Brown will sign the bill, or, believe it or not, veto it. These tax bills represent a 3 billion dollar tax hike for small businesses in Oregon. That's quite a voting block and a tax hike of that size will give republicans and moderates a lot to work with in the coming election cycle. We will learn the outcome in the coming days.
